VERIFICATIONS REQUIRED FOR ELIGIBILITY

At the time of your interview, you will need to bring in the following verifications.

Your interview may not be completed without the appropriate verifications.

-  **VALID STATE ISSUED I.D. OR DRIVER'S LICENSE FOR EACH ADULT MEMBER OF THE HOUSEHOLD.**
-  **ORIGINAL OR CERTIFIED BIRTH CERTIFICATE FOR EVERY MEMBER OF YOUR HOUSEHOLD 18 years and under**
(Hospital certificates will NOT be accepted.)
-  **I.N.S. VERIFICATION OF CITIZENSHIP STATUS**
-  **SOCIAL SECURITY CARDS FOR EVERY MEMBER OF YOUR FAMILY.**
-  **STUDENT ENROLLMENT:** Please have the name of your school, phone number, address and email address of the registrar's office.
-  **EMPLOYMENT:** Check stubs preferably for the last six (6) pay periods. If you are unable to provide check stubs for six pay periods, bring as many of the most recent check stubs as you have. Please include an email address for HR.
-  **STUDENT ENROLLMENT:** Please have the name of your school, phone number, address and email address of the registrar's office.
-  **SOCIAL SECURITY INCOME** - Bring in a computer printout that is not more than ninety (90) days old or your most recent benefits letter from the Social Security website.
-  **IRS RETURN** - Bring a copy of your most recent tax return, if you are self-employed, including Schedule C.
-  **VA INCOME** - Bring the award letter from the Office of Veteran's Affairs that is not more than ninety (90) days old.
-  **CHILD SUPPORT** - Bring a printout from the child support office even if you do not receive child support. You would need to make sure all children are accounted for.
-  **WORKMAN'S COMPENSATION or UNEMPLOYMENT BENEFITS:** Bring in most recent letter of notification of benefits if you have been unemployed for less than a year.
-  **REGULAR CONTRIBUTION/GIFT INCOME**- Bring your contributor with you to the appointment.
-  **401 K/RETIREMENT:** Please bring a copy of your most recent statement.

APPLICATION FEE: \$15.00 PER PERSON 18 YEARS OF AGE AND OLDER.

FAILURE TO PROVIDE ALL INFORMATION OR DOCUMENTATION NECESSARY FOR DETERMINING YOUR ELIGIBILITY FOR HOUSING ASSISTANCE MAY RESULT IN YOUR APPOINTMENT HAVING TO BE RESCHEDULED.
